## DOCUMENTS NEEDED TO OBTAIN A DELAWARE TITLE AND REGISTRATION FOR YOUR VEHICLE

	Manufacturer's Statement of Origin. (Must be properly transferred to new owner.)
	Out of State Title (Must be in owner's name or properly transferred to new owner. Out of state titles must be notarized if stated notary seal required.)
	Copy of Lien Agreement or Contract (A disclosure statement is <b>not</b> acceptable)
	Proof of liability insurance on the vehicle being titled. (This can be the insurance policy, an insurance card verifying liability, or assignment notice or binder. Whatever is presented must identify the vehicle or the fact that all vehicles owned by applicant are properly insured.)
	Vehicle must be presented for a safety inspection at one of our Motor Vehicle Division Inspection Stations.
	This application for Delaware title must be signed by the owner, (or if the vehicle has co-owners, <b>all</b> owners must sign.)
	Applications for title in a company's name must be signed by an officer of the corporation, or accompanied by an original notarized power of attorney.

	Delaware Driver's License or Proper Identification Required.
